

- III. To borrow or raise or secure payment of money in such manner as the TRUST may think fit and to secure the same or the repayment or performance of any debt, liability or contract, guarantee other engagement incurred or to be entered into by the TRUST in any way.
- IV. To permit any agents or any other persons authorised by the TRUST to use and occupy any building, erections or other property of the TRUST on such terms and conditions as the TRUST may deem fit.
- V. To enter into any arrangement with any Government or authority Central, State, Municipal or otherwise in pursuance of the objects of the TRUST and to obtain from any such Government or authority all rights concessions and privileges which may seem conducive to the TRUST's objects or any of them.
- VI. To undertake and execute Charitable Trusts.

6. MANAGEMENT:

The management of the TRUST shall vest with the Board of Trustees which shall comprise of not more than SEVEN Trustees.

7. THE TRUST:



22. INDEMNITY:

BNG (U) YLNR / 375 / 2004-2005 18-19

No amendments to the Trust deed shall be made which may prove to be repugnant to the provisions of Sec, 2(15), 11, 12 and 13 and 80 G of the Income Tax Act, 1961 amended from time to time.

24. DISSOLUTION AND DISTRIBUTION OF ASSETS:


