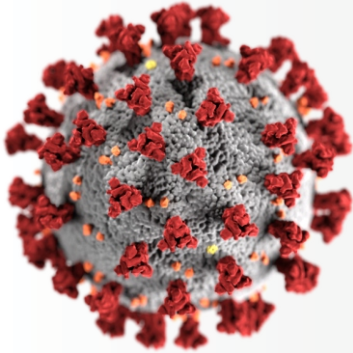
“To create learning opportunity, Releasing Potential, Achieving Excellency, Higher Standards, Better Knowledge system for rural youth and all”
